Total summer enrollment: 17 students.

Provided daily lectures with PowerPoint presentations, and used a variety of assignments including two essays, online writing exercises, an exam to teach course content and skills.

Fostered critical thinking skills, such as an in-class exercise involving a "mock archaeological site" so that students learned to differentiate between romanticized stories and historical realities by analyzing objects.
